**Re: Water Supply – Section 5410 – Hundred of Strangways, Livingstone
Proposed Abattoir**

I refer to your email of 6th July requesting indicative headworks water costs to your proposed development. I understand from verbal advice your loads are between 2.1 and 3.2 Megalitres/day of potable water to a proposed site on Section 5410, Hundred of Strangways.

PWC has carried out very preliminary modelling that indicates a new water main would be required to be built from PWC's underground trunk main adjacent the future Treatment site, Cox Peninsular road. From the water treatment plant site to the nearest corner of your site is just over three kilometres. A dedicated DN300 main would be required to your site and it would be necessary for you to install tanks at your site to hold a day's supply as the water transmission mains are not continuously pumped. It would also be necessary for you to install disinfection or chlorination system at your site to augment residual chlorine levels until PWC has established its proposed new treatment facility (5 to 10 year time frame).

The estimated costs for the water main extension are in the order of \$3M to \$4M Including road crossings and connections. Additional metering installation costs and developer charges have not been included; these will need to be determined following confirmation of your peak flows.

The potential water consumption you have verbally advised is substantial and as such we would like to discuss water conservation options as the project design proceeds
