20/02/2024. Officers from the Department of Environment, Parks and Water Security (DEPWS), observed plastic litter within a stormwater drain and on the rear boundary fence line of a premises located at 875 Stuart Highway, Holtze.

The actual and potential causes and contributing factors to the non-compliance.

Litter observed beyond the boundary fence line.

Soft plastic stored in Bins which were not lidded. During a storm soft plastic was blown outside of the bins. Plastic contained on site boundary fences, and then transported by overland flow to the stormwater discharge point.

The risk of environmental harm arising from the non-compliance.

The incident raised a risk of litter in the land and waterway adjacent to the site. After litter was recovered there was no residual impact to the environment.

The action(s) that have or will be undertaken to mitigate any environmental harm arising from the non-compliance.

On becoming aware Cleanaway cleaned up the litter within the yard and beyond the fence line.

Corrective actions that have or will be undertaken to ensure the non-compliance does not reoccur.

The plastic litter was collected both on the premises and on the other side of the boundary fence.

Storage bins replaced with lidded container.

Bailing machine fixed and plastic inventory reduced.

Additional "Trash Rack" netting installed to catch soft plastic before reaching the site stormwater discharge point.
