TRANSPORT POLLUTION INCIDENT RESPONSE MANAGEMENT PLAN

BULK LIQUID CARRIERS NORTHERN TERRITORY EPA LICENCE NUMBER

All tanker drivers are to be tool-boxed on this PIRMP (annually) and undertake daily pre-start checks on all vehicles to reduce the likelihood of a leak or spill.

Industry is now required to report pollution incidents *immediately* to ALL regulatory bodies.

POLLUTION INCIDENTS

Bulk Liquid Carriers is required to report pollution incidents **immediately** to the relevant EPA, the relevant Local Authority (Council), SafeWork NSW (Workcover), WorkSafe Vic, NTWorkSafe, Fire and Rescue NSW, Fire and Rescue Northern Territory and CFA / MFB Vic and SES Vic.

The definition of a pollution incident is:

"pollution incident means an incident or set of circumstances during or as a consequence of which there is or is likely to be a leak, spill or other escape or deposit of a substance, as a result of which pollution has occurred, is occurring or is likely to occur. It includes an incident or set of circumstances in which a substance has been placed or disposed of on premises, but it does not include an incident or set of circumstances involving only the emission of any noise."

A pollution incident is required to be notified if there is a risk of 'material harm to the environment', which is defined as:

- a) harm to the environment is material if:
 - 1. it involves actual or potential harm to the health or safety of human beings or to ecosystems that is not trivial, or
 - 2. it results in actual or potential loss or property damage of an amount, or amounts in aggregate, exceeding \$10,000 (or such other amount as is prescribed by the regulations), and
- b) loss includes the reasonable costs and expenses that would be incurred in taking all reasonable and practicable measures to prevent, mitigate or make good harm to the environment.

Notification Protocol

Call 000 if the incident presents an immediate threat to human health or property

If the incident clearly requires notification, e.g. truck rollover losing all contents and liquid entering creek, the driver shall notify 000 immediately, followed by the Operations Manager who will then notify the relevant authorities and government bodies.

If the driver is unsure if the incident requires notification, they will advise Operations Manager to determine if notification is appropriate, if so, the Operations Manager will notify all relevant departments.

The driver is to assist the Fire Brigade as far as practical in the clean-up and/or advising the local residents.

To minimise the risk of a spill the driver will undertake a Daily Prestart check and 6 Monthly Compliance checks in line with Bulk liquid Carriers Standard Operating Procedures, to ensure the truck is in good working order and all safety and spill kit equipment is in working order.

POLLUTION INCIDENT REPORTING

The following procedure needs to be followed:

- 1. When a pollution incident occurs, a person who has become aware of it must immediately bring it to the attention of his/her immediate Operations Manager or Managing Director
- 2. If necessary, first ring '000' for Emergency Services
- 3. Operations Manager or Managing Director listed above, is to **immediately** notify each Relevant Authority.
- 4. In borderline situations, where the exceedance of the trigger level of "material harm" of a pollution incident may not be clear, a quick assessment including consultation with Operations Manager or Managing Director should be undertaken to help the decision whether to notify or not.
- 5. A record of notification details must be recorded on the Pollution Incident Notification Log attached as Appendix 3
