When the non-compliance was detected and by whom. 26th June 2020 - Emma Fakes/ Amy Dysart/ Skefos Tsoukalis The actual and potential causes and contributing factors to the non-compliance. Condition 16: flow of discharge has not been monitored continuously. Power and Water have always been transparent with the Department of Environment and Natural Resources (DENR) that many remote wastewater sites are unmetered. The cost of metering remote sites is significant as often power is not available and Power and Water was required to source additional funding for the project and was subject to approval from IES through the budgetary process that is not aligned to the licence requirements, which subsequently resulted in being non-compliant from the date the licences were issued. Power and Water have implemented a risk-based approach for priority sites based on continuous flow to the environment. Power and Water had anticipated flowmeters would have been installed within 2019 - 20 however delays have occurred due to the uncertainty associated with accessing aboriginal communities as a result of the COVID 19 restriction. The flowmeter installations have had to be deferred to 2020 - 21, although funding remains uncertain. The risk of environmental harm arising from the non-compliance.
