## Pancho Beef - NTP 7061 Mathison Station – native vegetation clearing (4517 ha)

## **Summary:**

The Department of Industry, Tourism and Trade has reviewed the referred project and provides the following information:

The proposed land clearing at Mathison Station does not impact any mineral titles.

Please be advised GRO5 is also located within the proposed area, a geothermal reserve prevents the exploration or production of geothermal energy within the area. No pipeline interests effect the project area.

The proposal for land clearing of Mathison Station is broadly supported by the Agriculture Division (DITT) as it is in line with the economic objectives of Northern Territory Government.

The identified improved pasture species for the purposes of growing hay and fodder crops are suited to the climatic conditions and soil types of the area.

The identified clearing area is relatively small compared to the size of the property and will greatly add to the self-sufficiency of fodder and reduce the introduction of biosecurity risks including weeds to Mathison Station.
