Condition 29.3 non-compliance: The plant crop irrigated with wastewater in the eastern irrigation area was not removed from the land.

Daniel McDonald on 16 July 2021 on review of EPL302 requirements when gathering information for the updated Annual Monitoring report prepared by EcOz.

The actual and potential causes and contributing factors to the non-compliance.

Contractor commissioned to undertake the cropping and harvesting was unable to complete the work

The risk of environmental harm arising from the non-compliance.

No risk. There was no runoff of irrigated wastewater off-site. All irrigated water either infiltrated into the soil or was taken up by the grasses existing on the site. As outlined in Section 6 of the updated annual Monitoring Report submitted to the NT EPA on 20/07/2021, the concentrations of nutrients (TN, TP) would not result in adverse soil impacts. The total load of TN to the eastern irrigation area was 64.3 kg and total load of TP was 13.6 kg. For comparison, the TN and TP removed by a single forage sorgum crop planted and harvested on the 4.85 ha irrigation area would be 254.6 kg (TN) and 36.4 kg (TP) respectively.
