

## APPLICATION FOR CDS COORDINATOR APPROVAL

This is the approved form for applications for approval to carry on business as a CDS coordinator under the *Environment Protection (Beverage Containers and Plastic Bags) Act 2014* (the Act).

It is intended that this form will be read in conjunction with the Act and the *Guidelines for CDS Coordinator*.

### The Container Deposit Scheme (CDS)

A CDS Coordinator means a person who:

- (a) whether personally or through an agent:
  - a. coordinates the activities of CDS participants under CDS; and
  - b. collection, handles and delivers for reuse, recycling or other appropriate disposal, regulated containers received from collection depots; or
- (b) carries on activities of a kind of prescribed by the regulation.

A CDS coordinator approval means an approval under Part 2, Division 6 of the Act to carry on business as a CDS coordinator.

### CDS Coordinator Approval Application

An application for CDS coordinator approval must:

1. Be made in this approved form;
2. Be accompanied by a copy of each proposed waste management arrangement relevant to the approval;
3. Be accompanied by any additional information to enable the NT EPA to decide the applicant.

Please ensure all information and documents provided in conjunction with this application are accurate and truthful. It is a ground for suspending or cancelling a collection approval that the approval was granted because of a materially false or misleading representation.

Please note, it is not necessary for a CDS coordinator to have an operator arrangement to maintain their CDS coordinator approval. Arrangements will need to be made in the coordinator arrangement for other CDS coordinator to process containers on your behalf.
