

## FEES ASSOCIATED WITH ENVIRONMENT PROTECTION APPROVALS AND ENVIRONMENT PROTECTION LICENCES

## **Environment Protection Approvals and Licences**

The Waste Management and Pollution Control Act ("the Act") requires a person conducting an activity specified in Schedule 2 of the Act to have an environment protection approval or licence. The Waste Management and Pollution Control (Administration) Regulations ("the Regulations") prescribe fees associated with applying for, renewing or amending environment protection approvals and licences.

Fees associated with an environment protection approval include:

- Application fee;
- Fee to amend the conditions of the approval.

Fees associated with an environmental protection licence include:

- Application fee;
- Annual fee;
- Fee to amend the conditions of the licence;
- Renewal fee.

Application fees for environment protection approvals or licences must be paid before applications will be processed by the NT EPA.

In addition, upon application, annual fees for environment protection licences must be pre-paid for the first 12 months that the licence will be in force.

All applications must be submitted online in the NT EPA Online system. <a href="https://www.ntlis.nt.gov.au/ntepa">www.ntlis.nt.gov.au/ntepa</a>.

## **Fee Calculations**

Fees for Environment Protection Licences and Approvals are calculated using Revenue units. Each financial year the value of a Revenue Unit is assessed and published. There is also guidance on how to calculate fees using Revenue units on this site Revenue Units.

Annual fees are payable for each year an environment protection licence is held. Annual fees are payable in advance and the NT EPA will issue an invoice for annual fees.

Should there be any discrepancy between this document and the Act, the Act prevails.

On submission of an application in NT EPA online, the total fees payable will be calculated and an invoice issued electronically. The fees can be paid electronically in NT EPA Online using a credit card.

The NT EPA cannot process the application until the applicable fees have been paid.
