

Application for NT CDS Supplier Registration

Pursuant to Section 41A of the
Environment Protection (Beverage Containers and Plastic Bags) Act 2011 (the Act)

Guidance on completing this form

Beverage suppliers (manufacturers, distributors and retailers) must hold a CDS supplier registration certificate to supply regulated containers for sale in the Northern Territory (NT).

Information that you provide in this form will be used for the purpose of assessing your application to register as a CDS Supplier under the Act.

You must complete each section in the form, including all fields marked with an asterisk (*), and the declaration. Failure to provide a complete application will delay consideration of your application. Guidance and explanatory notes are provided below.

Applicant details

This section relates to the person or entity seeking registration as a CDS supplier. Registration may be issued to an individual(s), a company, body corporate or public authority, but not a partnership, trust or joint-venture name.

Supplier name: Enter the legal name of individual(s), company, body corporate or public authority seeking to register as a CDS supplier. If the supplier is a partnership or trust enter the full name of each person that represents the partnership or trust.

Company and/or Business number: Enter the supplier's company or business number/s as applicable.

- ACN – Australian Company Number is a 9 digit number issued by the Australian Securities and Investments Commission. If the supplier is a registered Australian company enter the ACN
- ABN – Australian Business Number is an 11 digit number issued by the Australian Business Register and used to identify an Australian business (e.g. sole traders, trusts, companies and partnerships). If the supplier is an Australia business enter the ABN
- Other business or company ID – for a registered business or company outside of Australia

If the supplier is a registered Australian company enter the ACN; if the supplier is an Australian business enter the ABN (enter both if applicable). Otherwise enter the supplier's registered business or company ID.

Business address: Enter the registered business address of the supplier.

Terms used in the declaration

Supplier arrangement

A supplier arrangement is a waste management arrangement between a supplier and an approved CDS coordinator. It provides for regulated containers supplied in the Northern Territory by a CDS supplier, and includes provisions to deal with matters such as payment by a supplier to a CDS for costs associated with including the containers in the CDS.

To satisfy the requirements for CDS supplier registration, the arrangement:

- Must be in the name of the supplier (e.g. full company or business name)
- must contain provisions that deal with the matters mentioned in section 11(2) of the Environment Protection (Beverage Containers and Plastic Bags) Act 2011 (the Act)
- must contain only provisions that are appropriate for the CDS
- must not contain provisions inconsistent with the Act
- Must be executed (signed by the supplier and CDS coordinator) and attached to the completed application and declaration attesting to the above.

A CDS supplier must, as condition of registration, at all times maintain a supplier arrangement.

Regulated containers

Each regulated container must satisfy the following requirements for supply in the Northern Territory:

- the container materials (including the labels) must be suitable for recycling or reuse
- the container must bear the approved refund marking
- the way the refund marking is applied is not likely to render the container unsuitable for recycling, for example it is not likely to be detached from the container when the contents are consumed (such as if applied to the lid)
- the supplier must have a supplier arrangement with an approved CDS coordinator, for the container.

Suitability of containers for recycling or reuse

Empty CDS eligible containers are returned through the CDS to an approved CDS coordinator to be recycled or reused. CDS coordinators are best placed to assist with questions about whether a particular container (including the label) or its materials are recyclable or reusable.

2. Applicant Declaration²

I _____ of _____
solemnly and sincerely declare as follows:

1. The supplier named in section 1 of this form (the supplier) has a supplier arrangement with an approved CDS coordinator (the supplier arrangement).
2. The supplier arrangement includes provisions that deal with each of the following matters:
 - collection, sorting, aggregation and transportation of the containers when empty;
 - the reuse or recycling of the containers when empty;
 - payments to be made by the supplier to the CDS coordinator in relation to dealing with the containers accepted by the coordinator;
 - a dispute resolution process for settling disputes between the parties to the arrangement;
 - the supplier arrangement contains only provisions that are appropriate for the CDS, and does not contain provisions inconsistent with the Act.
3. Each regulated container that the supplier currently supplies or will supply in the Northern Territory (NT) is or will be (at the time of supply in the NT):
 - the subject of a supplier arrangement to which the supplier is party
 - made of materials suitable for recycling and reuse
 - bear the approved refund marking, and the way the refund marking is applied does not render the container unsuitable for recycling
