STATEMENT OF ENVIRONMENTAL AUDIT

- I, John Michael Nash, of Douglas Partners Pty Ltd, a person appointed by the Environment Protection Authority of Victoria ("the Authority") under the Environment Protection Act 1970 ("the Act") as an environmental auditor for the purpose of the Act, as recognised in the Northern Territory, having:-
- been requested by the <u>Department of Natural Resources</u>, <u>Environment</u>, the <u>Arts and Sport</u>, and <u>Hammer JV Pty Ltd</u> to issue a statement of environmental audit in relation to the site located at 21 Goyder Road, Parap ("the site"), known as '<u>Stage 2' or Part Lot 7468 Salonika Street</u>, <u>Parap</u>, <u>Northern Territory (formerly part Lot 4669 (No. 21) Goyder Road</u>, <u>Parap</u>.
- 2. had regard to, amongst other things;
 - (i) relevant guidelines issued by the Victorian EPA and endorsed by the <u>Department of Natural Resources</u>, <u>Environment</u>, the <u>Arts and Sport</u>, and Department of Planning and Infrastructure, Northern Territory, including guidelines issued by the National Environment Protection Council;
 - (ii) the beneficial uses that may be made of the above site; and
 - (iii) relevant environment protection policies, related waste management policies, and planning instruments;

in making a total assessment of the nature and extent of any harm or detriment caused to, or the risk of any possible harm or detriment which may be caused to, any beneficial use made of the site by any industrial processes or activity, waste or substance (including any chemical substance);

and

3. completed an environmental assessment and audit in general accordance with Section 53X of the above Act so far as it applies to the Northern Territory, a copy of which report and statement of environmental audit have been sent to the Department of Planning and Infrastructure, Northern Territory.

HEREBY STATE that I am of the opinion that:

- 1. The site is suitable for the following beneficial use(s) subject to the recommended conditions noted below:-
 - Residential (land use) with minimal opportunities for soil access: includes dwellings with
 fully and permanently paved yard space such as high rise apartments and flats, as defined
 as Human (Health) Exposure Setting 'D' in the National Environment Protection
 Measure (Assessment of Site Contamination) Measure, National Environment Protection
 Council, 1999); and
 - Other less sensitive uses as defined by human (health) exposures setting 'F' as defined in the same document.

Recommended conditions of the audit are:

- Groundwater should not be abstracted from the site for drinking supply purposes; and
- A suitably worded agreement to this effect should be made between the relevant parties and be issued in the appropriate form and under the relevant Authority to implement this restriction.

- 2. An unconditional Certificate of Environmental Audit is not issued for the site. The reasons for which are presented in the site reports and are summarised as follows:
 - Concentrations of the heavy metals copper and zinc are present in soil within the site
 which exceed the EIL/PPIL for those substances.
 - Trace levels of the same metals were found in groundwater samples which were above the trigger levels for the protection of 95% of species published in the *Australian and New Zealand Guidelines for Fresh and Marine Water Quality*, (Australian and New Zealand Environment and Conservation Council & Agriculture and Resource Management Council of Australia and New Zealand, 2000).
 - Lead as noted in the Environmental Audit Report for the adjacent site (Stage 1) was in one sample above the Australian Drinking Water Guideline levels published by the National Health and Medical Research Council and Agriculture and Resource Management Council of Australia and New Zealand, 2004).
