**TAKE NOTICE THAT,** I Jim Grant, the Chief Executive Officer pursuant to the *Waste Management and Pollution Control Act* NT ("the Act"), have reason to believe that:

1. on a date or dates presently unknown to me in late 2009 and early 2010, during the loading of copper concentrate on ships at the premises, substantial quantities of copper concentrate dust escaped the loading equipment at the premises and were deposited onto the premises and into Darwin Harbour;
2. on a date unknown to me in late 2009 a large quantity of copper concentrate dust directly entered Darwin Harbour from a discharge chute forming part of the loading equipment at the premises;
3. at the time of the events in paragraphs 1 and 2, the copper concentrate was in the possession or control, and/or was the responsibility, of OZ Minerals Ltd; and
4. by reason of the facts in paragraphs 1 to 3, OZ Minerals Ltd has committed offences against section 83(4) or 83(5) of the Act, and/or has contravened or failed to comply with section 12(1) of the Act.

**AND I HEREBY REQUIRE AND DIRECT** OZ Minerals Ltd to immediately take steps to ensure that in future no loading of copper concentrate onto ships is

undertaken at the premises unless there are adequate measures in place to avoid a repetition of the events in paragraphs 1 or 2 above, such as would entail a breach of section 83(4) or 83(5), or a failure to comply with section 12(1) of the Act.
