Details	The monitoring required under the Benthic Infauna Monitoring and Management Plan (BIMMP) was not completed during the 2023-2024 wet season. Due to ongoing negotiations with the Department of Climate Change, Energy, the Environment and Water (DCCEEW) causing delays in engaging a consultant to conduct the monitoring in the specified timeframe. The department are currently in the process of amending the approval, as per advice from the minister approved Independent Technical Reviewer, who has concluded that the objectives of the BIMMP have been met. DCCEEW have issued PWC an exemption to conducting the dry season BIMMP monitoring while the variations are being assessed.
