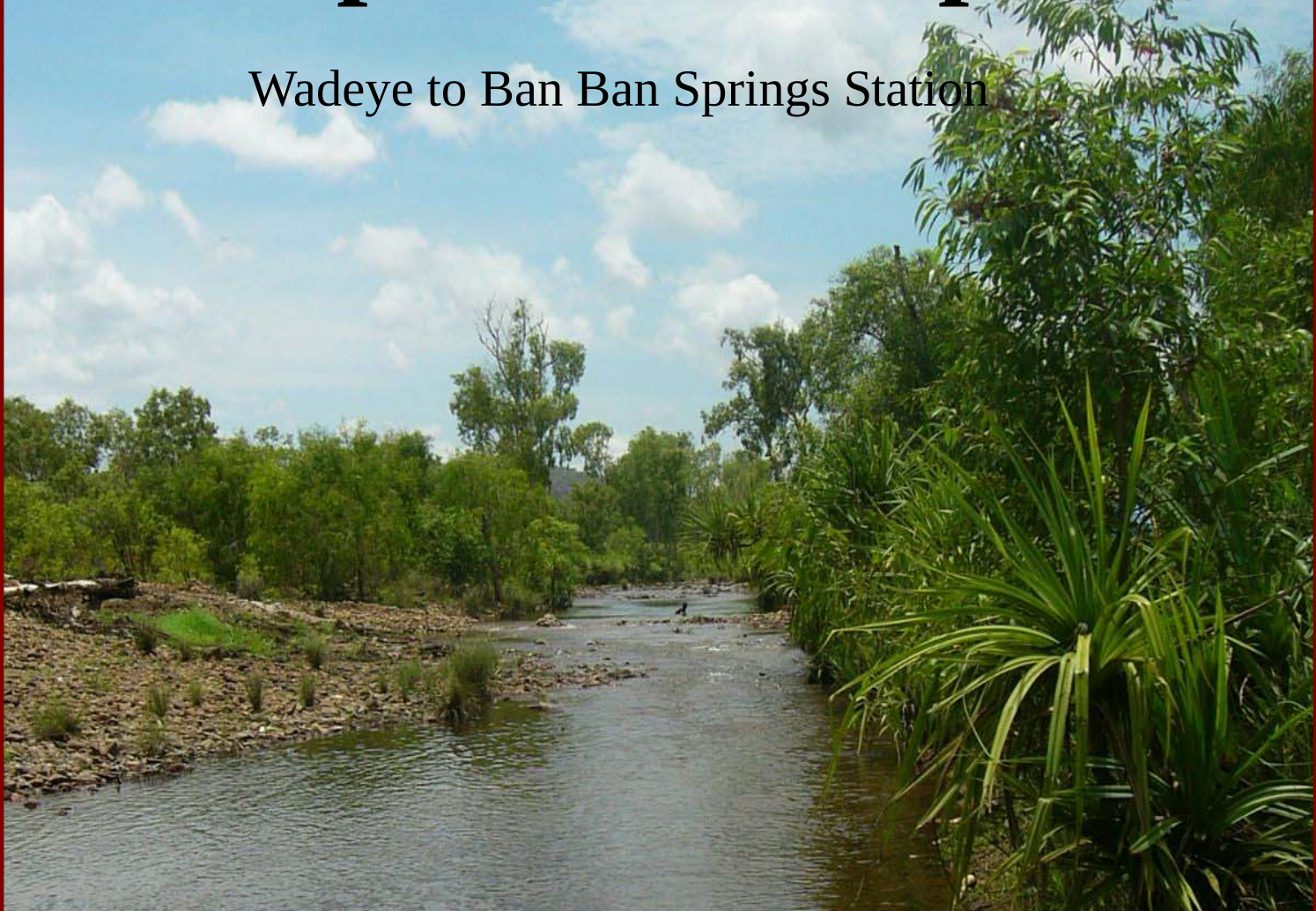

PUBLIC COMMENT

Australian Pipeline Trust proposes to construct a gas pipeline from the Blacktip Gas Plant near Wadeye (Port Keats) to meet the existing Amadeus to Darwin Gas Pipeline on Ban Ban Springs Station in the Northern Territory.

In accordance with the provisions of the Northern Territory *Environmental Assessment Act* and the Commonwealth *Environmental Protection and Biodiversity Conservation Act*, a Public Environment Report (PER) which describes the project and the potential environmental impacts has been prepared by Australian Pipeline Trust. The proponent has been directed to advertise the proposal and make the PER available for public comment. The public comment period is from 19th March to 30th April 2007.
